**2. Offshore Drilling Downhole Fishing Equipment and Abandonment Services**

  - *26" open hole by 20" casing.*
  - *Contingency for 20" open hole by 16" casing.*

  - *Contingency for 13 1/2" open hole by 11-3/4" casing.*
  - *12-1/4" open hole by 9-5/8" casing.*
  - *8-1/2" open hole by 7" liner.*
  - *Contingency for 8-1/2" open hole by 7-5/8" liner and 6-1/2" open hole by 5" liner*
- *Whipstock and casing exiting tools, for the fore mentioned hole sizes, both hydraulic and mechanical*

**4. Offshore Drilling Rig Pit Cleaning Services**

- *An appropriate equipment package to clean Synthetic Based Mud (SBM) from an Offshore Drilling Unit (Rig) low pressure mud system, including:*
  - *Cleaning SBM from pit walls and floors, all internal lines and internal equipment in the Rig's mud pits, trip tank, all sand traps, all shale shakers, the possum belly (distribution box or flowline trap) / header box and connecting lines and troughs.*
  - *Removal from the pits, lines and troughs of all SBM residue, SBM contaminated solids and all slops generated during cleaning, and transferred into fit for purpose skips/tanks/vessels to transport all SBM contaminated liquids and solids back to an agreed onshore delivery point for disposal.*
- *Specialist offshore personnel to prepare, install and operate such equipment*
