Confirm the appropriateness of the codes and standards selected. Assist ConocoPhillips in the development of the Scope of Validation Assist ConocoPhillips in the development of a Validation Scheme that outline the Scope of Work to be undertaken by the IVB services during the FEED and Execute phase of the development. Execute the Validation SoW in line with the Validation Scheme. This will consist of a combination of: <ul style="list-style-type: none"> Desktop design reviews (and independent analysis if necessary) Survey of specific Safety Critical Equipment at both vendor and shipyard Witness of critical tests Review of various records Issue various Validation Certificates in line with the completed Scope of Work and the requirements of the Scope of Validation.
