

**EXPRESSION OF INTEREST
PROVISION OF OFFSHORE JACK-UP DRILLING RIG**

ConocoPhillips is the operator of the Bayu-Undan Facility, which is located within the Timor Sea Joint Petroleum Development Area.

Pursuant to clause 10.1 of the Production Sharing Contract, ConocoPhillips is seeking expressions of interest from Companies capable of providing the below listed services to the Oil and Gas Industry who are a duly incorporated entity under the laws of República Democrática de Timor-Leste or Australia and who meet all of the following requirements:

Service Requirements

- *Provision of a Jack-Up drilling unit and crew to drill, complete and flow back offshore production wells and perform offshore well intervention workovers within the Bayu-Undan field and interfaced with the Bayu Undan Production Facilities.*

The site of the works will be located in offshore permit block/s located approximately 250km south-east of Suai in the Joint Petroleum Development Area (JPDA) of the Timor Sea.

The prospective contractor must have an offshore Jack-Up drilling unit which meets the following minimum requirements:

1. *IADC and ABS compliant.*
2. *Offshore environment suitability*
3. *Capable of interfacing with the existing Bayu Undan Production Facilities.*
4. *The Jack-Up drilling units must meet minimum technical criteria, as follows:*
 - i. *Water Depth Rating 120m (400ft);*
 - ii. *Rig Depth Rating 9140m (30,000ft) MD RT; and*
 - iii. *A minimum operating variable deck load of 2985 MT (8000) kips.*
 - iv. *Cantilever Requirements Skid: 21m (70ft) and Transverse: +/-4.5m (15ft)*
5. *The drilling unit must have an approved National Offshore Petroleum Safety and Environmental Management Authority (NOPSEMA) safety case or be working toward such compliance.*
6. *Provision of a fully qualified crew to operate and maintain the drilling unit.*
7. *Suitable drilling units would be available to commence the contract period as early as November 2017.*

Companies who meet all of the above minimum requirements are invited to submit their written expression of interest by email or hand delivery no later than **13 April 2016** for the attention of Reinalda Pires, Purchasing Officer.
